MESSAGE FROM THE PRESIDENT

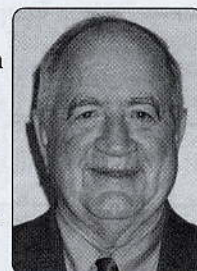
Greetings fellow alumni,

Association's most important task, we want to make sure that all the applications are correct and all of the necessary information is received. For example, school grades must come from the current school. This takes time so if you know someone who would like to be considered for a scholarship and is a Lehman High School Alumnus or a direct descendant, they should request an application by writing the Lehman Alumni Association – Scholarship Committee – P.O. Box 7498 – Canton OH 44705-7498, enclosing a stamped self-addressed envelope. There is a requirement that the alumnus be a member for two consecutive years. The application must be totally completed by May 1, 2007, so time is running out. If you have any questions, please give Tim Elder a call at 330-875-2323 or write to him c/o the above post office box.

Speaking of scholarships, last year's donations again were fantastic and will place our scholarship program on a very solid foundation. Of note are the donations made by Milan McManis, Norman Jackson, Nancy Morse Sonner, Evagilene Rapp for Mary Kay Wenger, and Lois Shank for Arlen Shank. Each donated at least one full scholarship or more. But maybe as important, we received over 200 Scholarship donations from our membership. That means more than a third of our active members donated funds to our scholarship program. That is amazing. Keep up the good work. Remember, each donation – no matter how big or small – goes into our scholarship fund. It all adds up.

Due to the tremendous success of our fund raising programs and to the generous donation made by Alumni members, last year we were able to raise the number of scholarships awarded from 25 Scholarships to 35 Scholarships. Donations continue to come in at a fantastic rate. As a result, the Trustees have raised the number of scholarships that can be awarded to 50 this year. That means we will be presenting \$25,000 in scholarships if we have 50 qualified recipients.

I would like to remind you that Canton Lehman High School Alumni Association has been granted exemption from Federal income tax under section 501(c) (3) of the Internal Revenue Code. The effective Date of Exemption is November 10, 2005. Contributions are deductible under section 170 of the code. Donors must have written substantiation from us for any charitable contribution of \$250 or more. It is the donor's responsibility to obtain written substantiation from this organization, but we have a procedure to automatically provide you with a letter. If you have donated over \$250 and have not received a

letter, please let us know, and we will send it immediately.

Our next scheduled event is the Pasta Dinner to be held at Faith United Methodist Church on 9th Street in North Canton on May 11, 2007, at 6:00 pm. Bring some friends and enjoy all the spaghetti you can eat. Tickets are \$7 and can be obtained from any of the Board Members or call me at (330) 494-9519

RECOGNIZING OUR ADVERTISERS

Looking back through past issues of the *Journal* for an advertiser who has been with us from the beginning of our requests for advertising to help cut our costs, there it was – EWING CHEVROLET

Perhaps it was because Stan Ewing, from the LHS graduating Class of 1939, had a soft spot in his heart for his alma mater that he stepped up and started advertising

Stan was the third generation of the Ewing family to take an interest in the automobile business. Although not born in Canton the family eventually moved here. After college Stan joined the family business in 1941 but only for a short time. WWII broke out, and he ended up in the Navy serving for 38 months on an attack transport in the Pacific.

Just because it was a family owned business did not mean Stan started at the top. While still in high school he worked for 12 cents an hour in the "Parts Department" earning gasoline money for the dealership's "rumble seat coupe" his father let him borrow.

The supply experience he gained in the Navy proved invaluable, and he moved up. After graduating from the Chevrolet School of Merchandising and Management in 1948, he joined his father as a Chevrolet dealer.

The history of Ewing Chevrolet tells how the dealership started in Jeromesville, Ohio, when Stan's grandfather saw the future of the automobile and in 1914 a "dealership" began. The copy of an order for a new car in 1916 showed the cost of \$571 included chains, an inner tube and a speedometer. A second dealership opened in Loudonville and stayed until the building burned down. When Chevrolet encouraged them to open a new dealership, Canton was chosen. In 1932 the first Canton Ewing Chevrolet Dealership was located at Cherry Ave. and 12th St. N.E. In 1937 they moved the dealership to 929 Cleveland Ave N.W.

The list of community organizations Stan has served in or contributed to is endless, but one recognition he received in 1991 was the Canton Chamber of Commerce's "Award of Appreciation" for outstanding service to the community.

In 2001 Stan was in the first class of alumni who received the LHS Alumni Distinguished Service Awards. His recognition was in the "Business" category.

Stan more recently served as President Emeritus of Ewing Chevrolet. Son David has been serving as President.

Perhaps one of the reasons Ewing Chevrolet stayed in business so long has been their commitment to integrity and treating each customer as an individual, guaranteeing customer satisfaction.

As this goes to press word came in that Ewing Chevrolet is closing its doors, and that is a sad day for this area, kind of like the closing of the doors to our alma mater.

A final tribute to Ewing Chevrolet for their support. As a matter of fact they paid for advertising through the end of this year, so it just shows how things can change in a blink of an eye.

Thanks Stan and Ewing Chevrolet for believing in our endeavors and being an Alumni Association advertiser for all of our years.
