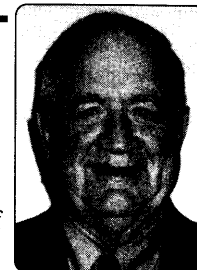



Next a report on your Association. I cannot believe the support from your Board of Trustees. Everyone has a particular area of expertise in supporting the goals of the Alumni Association. They all pitch in, and, as a result, we are moving forward by “leaps and bounds.” It is due to their dedication that we are able to report to you that last year was another extremely successful year for the Canton Lehman High School Alumni Association. Believe it or not, it is enjoyable to attend our monthly meetings. You are all invited to see how we accomplish our goals. Come and see them in action. We meet on the second Wednesday of the month at 7 pm at the GREATER CANTON AMATEUR HALL OF FAME. COME ONE, COME ALL!

During the next period the board will concentrate on the most important function of this Association – the processing of the scholarship requests and the selection and awarding of the Scholarships. Our Scholarship Committee, headed by Claudia Selby, will evaluate the requests. Tim Elder maintains the books, making sure that all the forms have been completed correctly and that they qualify for a Scholarship.

Since this is the Association’s most important task, we want to make sure that all the applications are correct and all of the necessary information is received. For example, school grades must come from the current school. This takes time, so if you know someone who would like to be considered for a Scholarship and is a Lehman High School Alumnus or a direct descendant, they can obtain an application on our website, CANTONLEHMAN.ORG, or can request an application by writing the Lehman Alumni Association – Scholarship Committee – P.O. Box 351 – Louisville OH 44641, enclosing a self-addressed stamped envelope. There is a requirement that the alumnus be a paid member for two consecutive years. The application must be totally completed and postmarked by MAY 1, 2012, so time is running out. If you have any questions, please give Tim Elder a call at 330-875-2323 or write to him c/o the above post office box.

Next comes the most difficult duty of the Board. Due to the large success of the Scholarship Program, we must now evaluate each individual’s request for a scholarship. Please understand that this is going to be an extremely difficult process, and Claudia and her committee will endeavor to do the most in-depth evaluation to award as many as possible.

Speaking of Scholarships, last year’s donations again were fantastic and will place our Scholarship Program on a very solid foundation. Of note are the donations made by Norman Jackson, Milan McMannis, BJ Wilkins, Elsie Campbell, Douglas McNeil, Evelyn Kolbl, Nancy Morse Sonner and the Class of 1942. Each donated at least one full scholarship or more. But just as important, we received 233 Scholarship donations from our membership. That means better than 1/3 of our active members donated funds to our Scholarship Program. That is amazing. Keep up the good work. Remember each donation no matter how big or small goes into our Scholarship Fund. It all adds up and do not forget that it is deductible.

Due to the tremendous success of our fund raising programs and to the generous donations made by Alumni members, last year we were able to award 50 Scholarships. Donations continued to come in at a fantastic rate. As a result, the Trustees have decided to continue to award at least 50 this year. That means we will be presenting a minimum of \$25,000 in

Scholarships if we have 50 or more qualified and selected requests.

I would like to remind you that Canton Lehman High School Alumni Association has been granted exemption from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code. The effective Date of Exemption is November 10, 2005. Contributions are deductible under section 170 of the code. Donors must have written substantiation from us for any charitable contribution of \$250 or more. It is the donor’s responsibility to obtain written substantiation from this organization, but we have a procedure to automatically provide you with a letter. If you have donated over \$250 and have not received a letter, please let us know and we will send it immediately.

Our yearly Pasta Dinner will be just like last year. As mentioned in the past, this event is not considered a fund raiser but a social get together. It will be considerably less labor intensive and provide a better environment for the social event. We will be holding this event at Rolando’s Restaurant at 2433 Whipple Ave NW on May 7, 2012, starting at 5 pm. Bring some friends and enjoy all the spaghetti you can eat. We will be awarding some door prizes. The Pasta Dinner will be \$8.00 and can be paid at the door. Bruce Williamson has made arrangements for Cleveland Cavalier Cheerleaders Ginny, Elise and Arika to join us for this event.

Next event will be the Memorial Day Parade on May 28, 2012. The Alumni Association has been in this parade for over 11 years but the number of Alumni members who come and march has dwindled to only a handful. Unless we can get some support from “you’all” then we will have to cancel this event. We meet in the morning at 9 am in the parking lot at Spiker, Foster, Shriver Funeral Home on 710 West Tuscarawas Street. We leave from that area and parade down Tuscarawas to the McKinley Monument. We have asked students who have received scholarships to help us by parading. 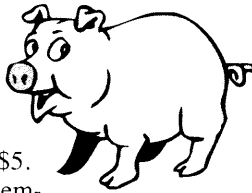

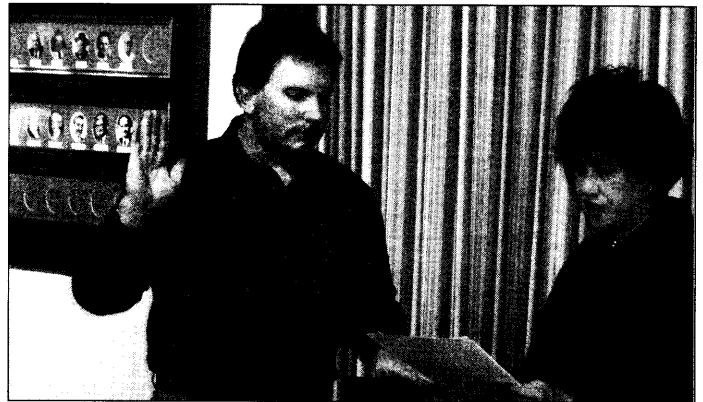
Probate Judge Dixie Park installed the following 2012 officers at the January 11 meeting of the Lehman High School Alumni Association:

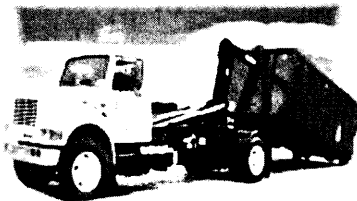

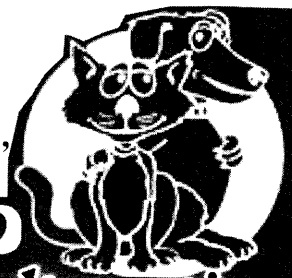

## STARK COMMUNITY FOUNDATION FUND FOR THE BENEFIT OF THE LEHMAN HIGH SCHOOL SCHOLARSHIP FUND

Over the last five years the Canton Lehman High School Alumni Association has been able to fund 50 scholarships each year and at the same time develop a reserve of \$25,000 for protection in a down economic cycle. Over the last three years we have turned our attention to developing a method to perpetuate the name of Canton Lehman High School and our Scholarship Fund.

We recognize that the Alumni population is maturing. Therefore we must plan for the future when the Association will not be able to fund our Scholarship program. In order to accomplish this, we have decided to invest our reserve funds in a Fund within Stark Community Foundation. Our hope is that this Fund will increase over the years to eventually be able to fund a continuing Scholarship program.

Stark Community Foundation is comprised of many prominent local funds such as the Timken, Belden and Hoover funds as well as many smaller funds, some of which have been established by well-known Lehman graduates such as Norman Jackson, B. J. Wilkins, Judge Harry Klide, the Schorsten family and the Sweitzer family to name a few. The Foundation started in 1963 and has returned over \$100 million to the community. By creating a fund with this organization, we will be able to pool our reserve funds to obtain better investment results.

An additional benefit (maybe more important) is that we will have a venue that will make it easier for our Alumni to endow funds such as charitable gifts (bequests). The Alumni may elect to place an amount in their wills to be distributed to this fund or Alumni may want to take out a Charitable Gift Annuity which will allow them to get the interest as often as quarterly, most of it being tax free, for the rest of their lives. There are many options for making a bequest that Alumni can take advantage in order to provide the Scholarship Fund an enduring life time. Some suggestions will be presented in this document to illustrate possible ways to make a bequest.

There will be no change in the present operation of the Canton Lehman Alumni Association as it will continue just as

it has in the past. Donations sent to our post office box will go into our Scholarship Fund, and we will continue to conduct the Scholarship program as we always have.

The Board of Directors of the Canton Lehman High School Alumni Association at their February 8, 2012, meeting unanimously approved our affiliation with Stark Community Foundation for many reasons. First, the Foundation will provide a professional management team to manage the assets of our Scholarship fund, allowing them to grow over time. Secondly, the Foundation will provide a conduit for you and your family to make estate planning decisions knowing your gift will continue its important work over a long period of time. Thirdly, it opens other options for gifts to our Scholarship Fund that you may want to discuss with your legal and/or investment advisers. We hope you share our vision to keep our scholarship giving alive for years beyond our own.

### WAYS TO DONATE BEQUESTS TO THE FOUNDATION FOR THE BENEFIT OF THE LEHMAN HIGH SCHOOL SCHOLARSHIP FUND

If you would like to make a contribution for the current year scholarships, please send it directly to the Canton Lehman High School Alumni Association, or you may choose to send a contribution to Stark Community Foundation for the benefit of the Canton Lehman High School Alumni Association Scholarship Fund to build the Endowment.

Many charitably-minded people have arranged for a future gift to their favorite charity by remembering that organization in their will or trust. By utilizing one of the creative alternatives outlined below, many people will find that they can provide adequately for their family – and still include charity in their planning. If you are in the process of completing or updating your estate documents, and would like to consider a charity or several charities in your planning, you may find the information presented below to be of particular interest. Remember the following items are only examples and it is highly recommended that one contacts their attorney, financial advisor or CPA for their own unique situation.

#### VARIOUS TYPES OF BEQUESTS

**GENERAL BEQUEST** – A general bequest provides that a specific amount of money, a percentage of your estate or a certain piece of property, be given to charity at the time of your death. For most people, a gift of a percentage of the remaining estate after taxes and debts have been satisfied is the most appropriate use of a general bequest. The following sample language illustrates how a general bequest to charity might be phrased in your will or trust:

*I give, devise, and bequeath 10% of my Estate, after taxes and debts have been satisfied, to Stark Community Foundation for the benefit of the Lehman High School Scholarship Fund.*

Many charities like to keep a record of those individuals who have included them in their will or trust so that they can keep these individuals updated on important issues and events within the organization.

The following simple language has been provided for your convenience if you wish to notify Canton Lehman High School Alumni Association.

Dear Sir (or Madam):

*I/we wanted to inform you that I/we have included your organization in our estate planning as a beneficiary. We have a great appreciation of your organization and are pleased to be able to provide for you in this way.*

*Sincerely yours,*

**THE TIME MAY BE RIGHT FOR A CHARITABLE GIFT ANNUITY** – Another method of providing support for the Canton Lehman High School Alumni Association is to purchase a Charitable Gift Annuity. With this instrument, you will receive a check quarterly, semi-annually or annually if you wish for the rest of your life. The amount will be the same every time. Year in and year out, it is the most popular life-income planned giving vehicle available, and since Canton Lehman High School High School Alumni Association will eventually benefit from the gift, the donor would have the satisfaction of assisting an organization they care about.

A Charitable Gift Annuity (CGA) can give you a higher rate of return than other investments, guarantee a steady stream of income and give you an immediate tax-deduction. Usually a portion of the income is tax-free!

Here is how it works based on a current illustration from Fifth Third Bank:

### WHAT IS A CHARITABLE GIFT ANNUITY?

A charitable gift annuity is a simple contract between you and CHARITY.

In exchange for your irrevocable gift of cash, securities, or other assets, CHARITY agrees to pay one of two annuitants you name a fixed sum each year for life. The older your designated annuitants are at the time of the gift, the greater the fixed amount CHARITY can agree to pay. In most cases, part of each payment is tax-free, increasing each payment's after-tax value.

Payments may be made annually, semiannually, or quarterly.

### EXAMPLE:

You irrevocable transfer \$10,000 in cash to CHARITY in exchange for a \$800 annuity for an annuitant, age 86.

### BENEFITS INCLUDE:

- 1) You will qualify for a federal income tax deduction of approximately \$5,625. Your deduction may vary modestly depending on the timing of your gift.  
Note that deductions for this and other gifts of cash and non-appreciated property will be limited to 50% of your adjusted gross income. You may, if necessary, take unused deductions of this kind over the next five years, subject to the same 50% limitation.
- 2) Your designated annuitant will receive fixed payment in semiannual installments totaling \$800 each year for life. In addition, \$694.40 of each year's payments will be tax-free for the first 6.3 years.
- 3) Your estate may enjoy reduced probate costs and estate taxes.
- 4) You will provide generous support of CHARITY.

**WHAT TO DO WITH "OBSOLETE" INSURANCE** – Do you have a life insurance policy you purchased years ago to provide financial protection – and no longer need it? If so, it may be a great asset to give Canton Lehman High School Alumni Association. Consider the benefits when you irrevocably name CLHSAA as both the owner and beneficiary of the policy.

1. You receive an income tax deduction.
2. You reduce the size of your taxable estate. At death, the face value of life insurance policies, depending upon the named owner and beneficiary, may be includable in the taxable estate of the deceased.
3. You leave your current income undisturbed.

We at Canton Lehman High School Alumni Association do not want you to jeopardize your security in making charitable gifts. At the same time, it's quite possible that you have either forgotten about an "obsolete" life insurance policy or consider it an unneeded asset. 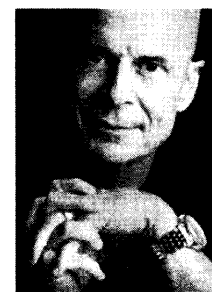

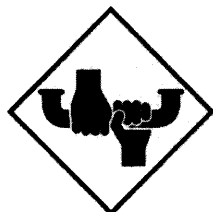

# ARTSINSTARK

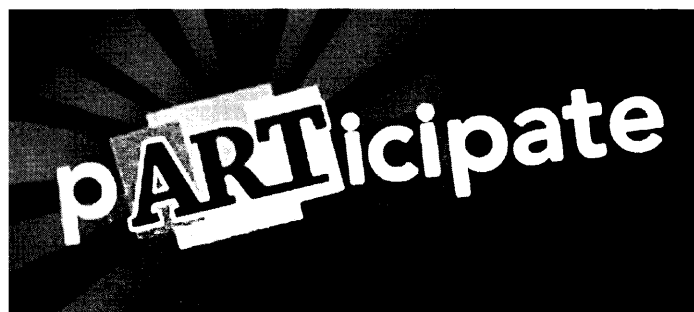

There is no question that the ArtsinStark program has made quite a difference in the Downtown Canton area.

What is the ArtsinStark program, how did it start and what are some of their plans for the future? The following may answer some of local area residents' questions:

A group was formed in 1968 to build the Cultural Center for the Arts. They now own the Cultural Center next door to the Canton Civic Center and the parking deck along with four smaller buildings around the Cultural Center including the ArtsinStark office on the corner of 9th Street and Cleveland Avenue N.W. and the church (ArtsinStark Education Center) across from Patrick's ice cream.

ArtsinStark is a non-profit organization, made up of eight employees, who award grants, manage the Cultural Center and run the Annual Arts Campaign, running now through May 23.



The mission of the organization is to create smarter kids, new jobs and stronger communities through the arts and economic development. One of the first things toward this purpose was the revitalization of Downtown Canton and the creation of the Canton Arts District (2nd Avenue N – 6th Avenue N between Cleveland and Market). What started to be one gallery five years ago has expanded to five galleries and over 25 artist studios.

Downtown Canton has also been the sight of local public art projects, including the cement decorated trash containers, an ArtsinStark project called "Garbage to Glory." It all happened when 20 different area artists gave of their talents and in turn made an announcement to the world that something very creative was happening in Downtown Canton. Since then, other projects, including a 10 foot tall, 50 foot long mural made out of six 800 pound steel panels called "Gaia's Hope," were in place. It tells the history of the world. When it was installed on the wall of the parking deck on Court Avenue between Second and Third Streets N.W. it announced a new era for public art in downtown Canton. Gaia's Hope was created by artist Joseph Close. Additionally "Shattered Expressions," designed by Tommy Morgan, express his artistic abilities in capturing the human expressions of joy, rage and sorrow. The wall where they appear is on the building at Fifth St. and Cleveland Ave. N.W. Vicki Boatright, and her signature cat murals, are also featured downtown, as are the large "critters" created by Patrick Buckohr and Shutter Bug, the work of PR Miller.

First Friday is hosted by ArtsinStark. Held on the first Friday of each month (even the cold ones), it draws a large group of

people to enjoy music, gallery openings, children's parades and great food in local restaurants. Anywhere from 3,000 people in good weather to 1,000 in cold weather take part in First Friday festivities, just for the pleasure of being a part of the ArtsinStark event that is sponsored by Stark Community Foundation, in association with the Special Improvement District (more info at [www.cantonfirstfriday.com](http://www.cantonfirstfriday.com)).

## 2012 SCHOLARSHIP APPLICATIONS

As a reminder, the application for 2012 scholarship awards can now be accessed through the [www.cantonlehman.org](http://www.cantonlehman.org) website.

The applicant must be a graduate of Lehman High School; or a direct descendant of a person who was a Lehman High School graduate or attendee during the years 1938 through 1976, who was a member last year and who has renewed their membership for 2012. An applicant who is a Lehman graduate also must be a member for both years. (There is a special rule if this "qualifying relative" is deceased.) The applicant must be a high school senior or graduate, or be a GED recipient. The application requires, in addition to the application itself, the latest available transcript, which can be a photocopy, a character reference from at least one unrelated person associated with your school (or a business associate if you are out of school,) and attendance at college or a letter of acceptance from the college you plan to attend.

We hope to award up to 50 \$500 scholarships again this year; if there are more than 50 qualified applicants, a selection committee and/or the Board will choose the awardees. The scholarships will be paid directly to the recipients therefore these should not affect any other scholarships the recipients may receive.

For those individuals not having computer access, forms may be requested by mail. Regular mail requests should include a stamped, addressed envelope (one stamp for each application requested; business size, or larger, envelope); and be sent to Lehman High School Alumni Association, PO Box 351, Louisville, OH 44641.

The application as well as all other information must be postmarked on or before May 1, 2012.




