
It's an evening to invite friends to come out and share conversation, eat, dance if you choose and see what is offered up for bids to benefit the Scholarship Fund.


NAMES IN THE NEWS

LENNY MAY of the Class of 1965 was inducted into the Chagrin Falls High School's Athletic Hall of Fame October 2 at the Chagrin Valley Athletic Club. The English teacher distinguished himself as a coach and athletic director at Chargin Falls High School. He was a varsity baseball coach for 18 years, and his teams compiled a 217-152 record. Six times he was named Chagrin Valley Conference Coach of the Year. In 1980 he was Geauga County Coach of the Year.

For 20 years he was an assistant football coach helping develop some of the finest athletes in the school's history. During his 12 year tenure as athletic director the athletic program grew to house 24 varsity teams. Four teams won state championships, and three were state runners-up. Individual athletes excelled at state and national levels. He has overseen 28 league championships in 11 sports.

WARD SCOTT '48 finally decided it was time to retire after the City of Canton wore him down and bought his building. After 42 years in the costume business it was turned over to the Canton Chair Rental Company, and all of Ward's employees were to become a part of the new business. We understand Ward still drops by to keep an eye on things.

DR. ROBERT RIPICH, DDS '59 was recently recognized in the Repository for making a "clean sweep" with a tongue sweeper. In 1999 Ripich patented the tongue sweeper and by the time of the writing, over 100,000 have been sold both in and out of the country, with some of his biggest accounts in Germany.

According to the article, in order to maintain a healthy pink tongue, it should be scraped in addition to brushing and flossing teeth. The normal toothbrush does not clean the tongue of bacteria and plaque which in turn can cause an individual to have less than pleasant breath. Sweeping the tongue may also reduce tooth and periodontal disease, which in turn may allow individuals to keep their teeth much longer.

The sweepers can cost anywhere between 99¢ made of plastic to \$30 made of titanium. Dr. Ripich recommends the stainless ones because they can be sterilized. His company is named Biocury Medical Instruments, and the products are made in Canton. They are available at many pharmacies, and some dentists sell them at their front desks.




Bill sold 42 of the 200 tickets and deserves a special salute for his efforts.

At the time of printing we understand their challenge is being well accepted. For those who already paid their 2004 dues, you may challenge them for half of your 2005 dues.






