

As a 21-year member of the Cathedral of Life Church, Mary Alice has served on the Ladies of Life Ministry where she assists members with clothing needs at the used clothing store she operates two days a week. She served on the church's board, which developed the Inn at Belden Village retirement home, and she was instrumental in the interior decoration of the home.

A long-time choreographer, Suzanne has choreographed more than 165 musicals and operas for Baldwin-Wallace and the Berea Summer Theatre. She also has worked with the Cleveland Opera and Greenbriar Theatre. In addition, she has directed or assisted in the direction of 20 musicals and plays. For her body of work, she received the 1980-81 Cleveland Critics Circle Award for Outstanding Choreography. In particular, she was cited for her work with productions of *The Music Man, Oliver, Cabaret* and *Music Hall*. She has been listed in Who's Who in Entertainment and Who's Who in America.

She received Baldwin Wallace's Bechberger Award, which is presented annually to a professor for their work with students outside of the classroom. She also received the Distinguished Faculty Award, presented annually to a professor who embodies the principles of Baldwin-Wallace's mission and goes far beyond the requirements of her position.

Suzanne and her husband Rudy live in Strongsville, Ohio.

DIANNE TALARICO - EDUCATION

Dianne Talarico, a graduate of Lehman High School in the class of 1975, has been an educator for 26 years. She has served as a teacher, assistant principal, principal, associate professor, director, associate superintendent for the San Francisco Unified School District and is currently serving as superintendent of the Canton City School District. She earned a master's degree in educational administration from San Francisco State University and a bachelor's degree in elementary education and learning and behavioral disabilities from Bowling Green State University.

Early literacy, leadership development, and establishment of strong partnerships with home, community, colleges and universities are what she embraces as pathways to improving student achievement. Dianne is very passionate about children and reading. Early literacy is essential to success in school. She believes that it is the combined responsibility of the home, the school and the broader community to ensure that all students achieve early literacy.

JAY WAGNER - ATHLETICS

Jay Wagner is a 1941 graduate of Lehman High School. He was inducted into the Army in 1942 and discharged in early 1943. He then attended Ohio State University, graduating with a B.A. degree in journalism and radio. While a student, he began working at WOSU, the university's radio station. He became sports director at the station where he had the opportunity to broadcast football, basketball and baseball games through December, 1945.

Upon returning to Canton, Jay worked at WHBC for six months before going back to Columbus as sports director for WCOL. He was at the microphone for the first high school game ever broadcast in Columbus. In 1960, he joined WERE in Cleveland and broadcast Ohio State football games for nine years on a 17 station radio network in Ohio which included WHBC. During that same period he filled in for Bob Neal on a series of Cleveland Indians games with Herb Score. He also did the play-by-play one year on television for the cable TV systems in Ohio with Rex Kern as colorman. Jay closed his broadcasting career in the early '70s when he served as president of the Ohio Sportscasters Association.

He has served on the board of directors and as president of the following organizations in Sandusky, Ohio: Jaycees, Lions Club, YMCA, Erie County United Fund, Rotary Club, Plum Brook Country Club and the Sandusky State Theater. He also served on the board of directors of Good Samaritan Hospital for 21 years.

Jay was appointed a member of the Executive Order of the Ohio Commodores by Gov. James Rhodes and served as Grand Commodore in 1989. He was elected by the voters of the 13th Congressional District of Ohio to the State Board of Education which he served for eight years. He was also appointed by the governor to the Board of Directors of the Ohio Lottery Commission and served as its chairman for three years.

Jay is currently a member of the Board of the Naples Ohio State Alumni Association, Vice President and Editor of the Quarterly newsletter. He is the corresponding secretary of the Lehman High School Class of 1941 and Editor of the twice-yearly newsletter sent to class members.

Unable to accept his award in person, Jay (who lives in Naples, Florida) was represented by his son Douglas.

BARBARA (MONTGOMERY) UDECK – SERVICE TO ALMA MATER

Barbara Udeck was born and raised in Canton and is a 1956 graduate of Lehman High School. She attended Clarendon and Summit Grade Schools before entering Lehman in the eighth grade.


