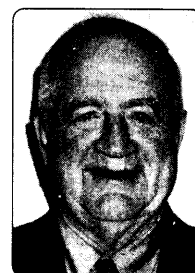

Shelley (Steiner) Hughes '75 is a candidate for the Alaska State House in 2012.


Joe Vitale '67 was the subject of an interview in the *Repository* about his reaction to the Rock and Roll Hall of Fame's most recent inductees.

SCHOLARSHIP APPLICATIONS FOR 2012 NOW AVAILABLE

The application forms for the 2012 Alumni Scholarship Awards are now available both online and by written request. These scholarships awards are for \$500 each and are paid directly to those recipients who will be pursuing advanced education beyond high school in 2012. Eligibility is restricted to Lehman graduates or direct descendants of anyone who attended Canton Lehman High School between the years of 1938 and 1976.

Applications are now available online, in both Excel and PDF formats, on the alumni website (www.cantonlehman.org). The Excel format will allow you to complete the application online and save to your computer. The PDF format requires you to print a copy and complete by hand. Forms may also be requested by mail. Send requests to *Lehman Alumni Scholarship Committee, P.O. Box 351, Louisville, OH 44641*.

The Canton Lehman High School Alumni Association scholarship program was initiated in 1994. Since those first six recipients, the Association has awarded \$234,000 to 466 young descendants of Lehman attendees. This success is the result of the continuing hard work and effort by members of the Association and very generous contributions by many of our former classmates who both appreciated their time at Lehman and believe in helping our children and grandchildren continue pursuing their education beyond high school.

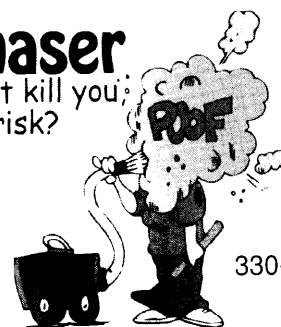
All applications must be postmarked no later than May 1, 2012. Those postmarked after that date will not be considered. Remember, normally only 50 scholarships are awarded annually, and the order in which they are received does factor into the final selection process. All applicants are eligible for up to a total of two awards, however a new application must be submitted in order to be considered for the second award.

BIOGRAPHIES OF 2011 LEHMAN HIGH SCHOOL ALUMNI OF THE YEAR

DAVE HORTON '68 – ARTS & ENTERTAINMENT

Dave Horton was born in Canton, attended Summit Grade School and graduated from Lehman High School in 1968.

He was a City of Canton Councilman from 1977-1979, but he was probably better known as a bartender at The Pub Club and Double Tyme.

Dave moved to California in 1984 and spent almost 11 years as an Insurance Investigator/Adjuster. After his career in the insurance field, he bought a printing business in Pasadena where he lives with his wife Gina. He is a proud veteran of the U.S. Navy.

In 2009, Dave travelled through Ohio during the height of the fall foliage season. This sojourn became the genesis for his book, *Small Towns, Country Roads & Autumn Leaves*, published in November 2010. The book was the subject of a lengthy article in the *Canton Repository* on November 17, 2011, in which his selection as a Distinguished Alumni was prominently mentioned.

DR. ROBERT FLEISCHER '59 – ATHLETICS

Bob graduated from Lehman High School in 1959. He came to Lehman from Woodland grade school where he led a team of outstanding basketball players who won the City Grade School Championship. They were so good that Coach Jim Robinson decided to coach them himself as a freshman team. Besides playing on the freshman team, Bob was elevated to the varsity that year. During his senior year, Bob broke all of the Lehman and the City scoring records for the most points in one game and for the most points scored in one season. His Lehman High School records stand today.

Also, during his senior year, Bob was named to the All American High School Basketball team. Bob is the only Lehman and Canton basketball player to receive this honor.

Bob is a highly regarded Doctor of Optometry practicing in Warren, Ohio.

DAN FINN '74 – BUSINESS

Dan Finn honed the skills necessary to succeed in business on the basketball court and in the classroom. While Dan was a freshman, he was a member of the 1971 State Championship Basketball Team. Dan is believed to be the only four-year varsity letterman in the school's history. A three-year starter, he contributed to some of Lehman's most successful teams ever, including its highly touted undefeated 1972-73 regular season.

His 1974 senior classmates voted him the school's Outstanding Boy Graduate and its Most Valuable Athlete. Further foreshadowing his future potential, he became a member of the National Honor Society during his junior year.

Following graduation from Ohio State University, he spent five years as a public school teacher and basketball coach, including a few substitute teaching assignments at Lehman Junior High, before transitioning to a career in business. During this period, he was active in several community organizations, most notably the Players Guild of Canton and the Stark County Bicycle Club.

Following a distinguished 25-year career with Nationwide Insurance where he received numerous "Consultant of the Year" awards, Dan founded the Finn Financial Group to better meet the needs of his growing national client base. Finn Financial is a specialty planning firm dedicated to helping protect the long-term financial stability of its clients.

Focused on helping clients save money by implementing tax-advantaged Structured Settlements and Attorney Fees, Structured Sales, Structured Oil & Gas Lease Bonuses, 401(k) Conversions and Retirement Rollovers, the Newport Beach, CA-based company is endorsed by some of America's most distinguished attorneys and Fortune 500 companies.

THOMAS I PIEPER '60 – CIVIC/COMMUNITY

Tom Pieper was born and raised in Canton, and attended Belle Stone and Summit Schools.

After graduating from Lehman High School, Tom attended Heidelberg College graduating in 1964 with a major in History and French. Tom began teaching in the Plain Local School District in 1964 where he spent the next 32 years, retiring in 1997. He was honored by his fellow teachers in 1972 by being named a Martha Holden Jennings Scholar in recognition of his work in education.

As a History major at Heidelberg, Tom was required to prepare a paper on a topic about which very little had been previously written. Tom selected Fort Laurens – the only Revolutionary War fort built by The Continental Congress in what is today Ohio. His paper won honors as the best Senior History Seminar paper prepared that year.

While working on his Master's degree at Kent State University, Tom asked and received permission to expand his earlier paper on Fort Laurens into his Master's Thesis, completed in 1967. In 1975, in anticipation of The American Revolution Bicentennial celebration, Kent State University Press asked Tom to re-work his Thesis for publication. With the assistance of his thesis advisor, James B. Gidney, he completed this project, and the book, *FORT LAURENS: 1778-1779, THE REVOLUTION IN OHIO*, was published in 1976 and is still in print today.

In 1993, Tom assisted in the formation of The Friends of Fort Laurens Foundation – dedicated to studying, preserving, promoting, and rebuilding Fort Laurens. Tom is currently Vice President and Chairman of The Board of Trustees.

To honor Tom's work with Fort Laurens, The Tuscarawas County Historical Society awarded him the Zeisberger-Heckewelder Award for 2011.

In addition to his involvement with Fort Laurens, Tom helped form The Plain Township Historical Society in 2005, and he currently serves as President and Chairman of the Board. The Society assisted Plain Township in celebrating its 200th anniversary in 2009.

His love of history also led Tom to serve as Archivist at his church, Trinity United Church of Christ, and he has served in this post for over 25 years.

Since college, Tom has also been an avid re-enactor of The American Revolution, traveling to hundreds of places, including Great Britain where he would speak and perform.

KENT SMITH '59 – ADMINISTRATOR/COACH/TEACHER

Kent was born in Canton, Ohio, attended Summit Grade School and graduated from Lehman High School in 1959. He was considered a decent all-around athlete; he earned eight varsity letters at Lehman, became a Captain and MVP in both football and basketball, and earned All-City and All-County recognition in both sports. In 1959, Kent was selected to, and played in, the North-South Ohio All Star Football game.

After graduation from Lehman, he entered Mount Union College where he lettered in football four years while receiving several "Hatchet Man" awards, and Ohio Athletic Conference mention as a linebacker. His teams in both sports became Division Champs several times with one of his basketball players being selected to play on the McDonald's All-American Basketball Team. During his four years in Germany, Kent earned his Master of Science Degree in Education/Administration from The University of Southern California/European Division. Kent then returned from Europe, accepted a position as head basketball coach at Jackson High School in 1977, and retired from the District in 1993.


In 1978, he also became a licensed realtor in the Stark County area and has over 30 years of experience in the field of real estate. A highlight was when he was honored as a RE/MAX Hall-of-Fame Realtor. He continues today to "teach and coach," but this time it's to buyers, sellers and investors of real estate. Kent's community activities have been many and varied. A couple of his favorites are his involvement as a member of the Pro-Football Hall of Fame Transportation Committee for more than 25 years and his association with the Lehman Over-the-Hill Gang's annual golf outings.

and athletic director. In 1968-1991 he was the Principal at Ottawa Hills Junior/Senior High School in Toledo. In 1994-2001, Jim was the Coordinator of Placement for the University of Toledo-College of Education.

Dr. Esber joined Merck & Co., Inc., in April 2001 as Executive Director for International Medical Affairs and Health Policy, assuming a leadership role in advocating for Merck & Co, Inc. medical and health policy vaccine interests with multilateral organizations while providing medical support for in-country activities in early preparation for product launches. At the time of her departure in December 31, 2008, she held the position of Strategic Advisor for Global Organizations, Medical Affairs and Policy, Merck Vaccine and Infectious Diseases (MVID).

In her capacity, she represented MVID with international multilateral organizations, including the World Health Organization (WHO), the GAVI Alliance, the Pan American Health Organization (PAHO), and the International Association for Biologics (IABS), as well as numerous other international organizations. She provided guidance and direction in advocating for Merck & Co, Inc. interests on the Ad Hoc Industry Group that discusses GAVI policy and activities, provided support for the GAVI Industrialized Vaccine Company Board member (a three year rotating position recently held by the MVID President), as well as on other international working groups. She chaired the International Federation of Pharmaceutical Manufacturers Association's (IFPMA) Biologics and

She received her medical degree from Ohio State University School of Medicine, completed her internship and residency at the Children's Hospital, Columbus, Ohio, and her clinical Pediatric Hematology/Oncology fellowship from Children's Hospital at the University of Washington in Seattle. Dr. Esber was awarded a fellowship to conduct tumor immunology research at the National Cancer Institute, National Institutes of Health (NIH), and continued her research activity while on the faculty of the Children's Hospital and the George Washington University Hospital, in Washington, D.C., prior to joining FDA.

Okay, now I remember. It's time to renew your 2012 membership. See, a little nap does help.

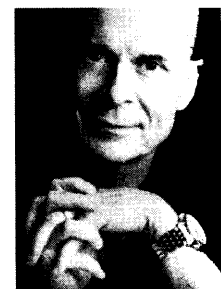

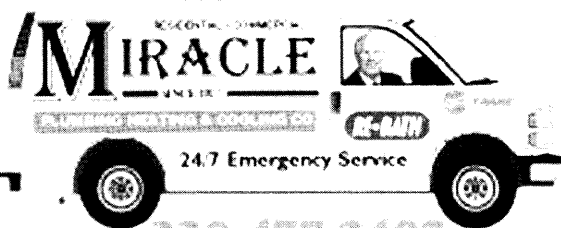
