ALUMNI ASSOCIATION FUNDRAISER

The Alumni Association recently was the beneficiary of a very generous offer from the Stark Community Foundation to double new contributions of \$10,000. Realizing that this was an offer we should not miss out on, the Board of Trustees unanimously elected to donate \$10,000 to our endowment, which with its matching \$10,000 grant increased our total Fund from \$25,332 to over \$45,000. We are sure that all Association members will agree that this was a very wise investment to build this endowment for future scholarship donations.

However, this investment, which was made from our current operating funds, must now be made up with additional donations from our members so that we may continue our current scholarship program. We have therefore initiated a special fundraiser to replace this money and are asking all of our members to contribute on a special one-time basis to assist us in replacing the \$10,000 so that we may continue awarding 50 scholarships this year. We would appreciate it if all of you who have not already contributed to this special fundraiser would consider donating an additional amount this year to allow us to make up this money. 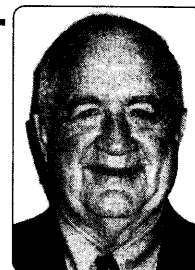
MESSAGE FROM THE PRESIDENT

THE CANTON LEHMAN ALUMNI ASSOCIATION FUND
IN THE STARK COMMUNITY FOUNDATION
RECENTLY TOOK A GIANT LEAP FORWARD.

Now for the details. As you may or may not know, we invested our reserve funds of \$25,000 in the Stark Community Foundation with a goal of establishing a fund that will preserve the heritage of the Canton Lehman High School far into the future by providing Scholarships in the future when the Association no longer exists.

This is an easy vehicle for Alumni to do some estate planning by providing some funds from their estate. This past year we received a "windfall" from the Stark Community Foundation that greatly enhanced that fund. For the 50th Anniversary of the Stark Community Foundation, they have made available \$500,000 and will give \$10,000 to each fund if that fund invested another \$10,000. Your Board felt it would be very prudent to take \$10,000 from our scholarship funds to get another \$10,000. In less than one year our funds have grown from \$25,000 to over \$45,000. Now we must replenish our Scholarship funds if we are to maintain our usual 50 Scholarships. We are currently holding a special fundraising campaign for that purpose.

Bill McClelland, Class of 1957, has made an eloquent video explaining the background of this event. It is on YouTube under Canton Lehman High School, and it is

DEBORAH FEZELLE '70 **ARTS & ENTERTAINMENT**

Deborah Fezelle graduated from Lehman in 1970. After graduating from Lehman, Deborah spent a year at Bowling Green State University before being accepted into the Drama Division of the Juilliard School in NYC.

She spent 25 years in NY working as a professional actress on Broadway & Off-Broadway. She's done film, TV & commercials. In recent years Deborah turned to writing & directing plays. Returning to Stark County 10 years ago to care for her ailing mother, she formed her own company, Top of the Town Productions. She's staged plays at the Palace Theatre, the Kathleen Howland Theatre, the Canton Club, Theater 8:15 in Green & Fieldcrest in North Canton. She recently served as Acting Coach on the feature film UNDERDOGS that was filmed here in Stark County. She will be filming her original web series THE EVIL THAT MEN DO in the area in the coming months.

LENNY MAY '65 **ATHLETICS**

Lenny May graduated from Canton Lehman in 1965. After high school, he graduated from Ohio University. In 1969, Lenny started his coaching career at Athens High School as an assistant coach and an English teacher. In 1970, Lenny went to Chagrin Falls High School to teach English and to become the Head Baseball Coach at the age of 23 and coached baseball for 18 years. Lenny became the varsity football assistant for 20 years. He taught English for 32 years serving as department chair for 20 years. In addition, he was the athletic director for 20 years.

Because of his coaching experience and his many years of Athletic Director, the Chagrin High School Baseball field was named the Lenny May field.

In 2003, Lenny May was inducted into the Chagrin Falls High School Hall of Fame as Teacher/Coach/Athletic Director, and in 2009, he was also inducted into the Northeast Ohio Baseball Coaches Hall of Fame.

When Lenny retired from teaching in 2004, the position of

Community Relations was created where he has held a part time position in 2009 and 2010. He has served as a volunteer football coach over the past four years including the past two years when Chagrin Falls went to the State Championship playing in Fawcett Stadium in 2009.

Lenny is married to Lana and has two daughters, three sons and three grandchildren. They currently reside in Twinsburg, Ohio.

ALEX J. GARCIA '65 **BUSINESS**

Alex Garcia graduated from Lehman High School in 1965. After high school he graduated from Ohio University with a degree in Business Administration with an Industrial Management major.

Alex was President/CEO Management for over 39 years in manufacturing engineering, business development and multi-plant operations management advancing to President.

In 1969 – 1972, Alex began his career at NCR Corporation in Dayton, Ohio, as an Assembly Methods Analyst. He was responsible for analyzing, improving and implementing improved manufacturing processes.

In 1972 to 1979, Alex worked at ESB (Exide) Corporation in Cleveland as a Staff Industrial Engineer supplying support to 16 plants strategically located throughout the United States. Alex moved from Cleveland to Dallas, Texas, as a Regional Industrial Engineer servicing several southern plants. He was promoted and transferred to the Atlanta, Georgia, plant as General Foreman responsible for all aspects of day-to-day plant activities.

In 1979 to 1987, he worked at Parker Hannifin Corporation as Plant Manager of the Non-Standard Tube Fittings Plant. Alex was promoted in 1981 to the position of Manufacturing Manager of the Eaton and Lewisville Ohio Plants where he was responsible for the management of 800+ employees and full P&L responsibility.

In 1987 to 1996, Alex worked for Masco Tech Corporation as the Plant Manager of the Royal Oak Plant, one of the top metal working operations in the world. He was promoted in 1993 to Group Director of Operations responsible for the management of four manufacturing plants with \$350 million in sales.

In 1996 to 1997, Alex was employed at Sinter Metals Incorporated as the Vice President of Operations of a new company that was consolidating the powder metal industry. In one year through mergers and acquisitions the company grew to 24 locations worldwide and he took responsibility for the 12 US and Canadian plants. The Company was taken public and then unexpectedly sold to a large international company.

In 1997 to 2006, Alex was hired as the President/COO of Colfor Manufacturing, a bankrupt company with locations in Malvern and Minerva, Ohio. In 1999 they acquired Valley Forge in Salem, Ohio. After turning the merged company to profitability, it was sold to American Axle Corporation. In December of 1999 Alex became President/CEO of FF Acquisition Corporation d/b/a Flexible Flyer located in West Point, Mississippi, another bankrupt Cerberus portfolio company.

In 2006 to present, Alex has consulted with Turn-Key Forging and Design (Division of Klein Tools) and Vadxx Energy. Since his "semi-retirement" in 2008, he has worked tirelessly for the advancement of business students at Ohio University. He donates many hours as part of the Business Schools advisory council, and more recently as a newly named Trustee for the University's Foundation. He recently returned from a trip to Italy where he helped mentor Ohio University business students who were involved in a hands-on project.

Alex Garcia has been married to Nancy for 43½ years. They have three daughters and seven grandchildren.

HELEN ELITE KOSTEL '52 **CIVIC/COMMUNITY**

Helen Elite Kostel, class of 1952 at Lehman High School, was the first woman president of the Student Council and the first and only woman director of the Canton Museum of Art. She graduated from Wells College and received her master's degree from John Hopkins University in art history.

After marrying George Kostel, an attorney from Clifton Forge, Virginia, Helen moved to this small town in Western Virginia. For 47 years, the Kostels have made a difference in Clifton Forge which was a victim of the decline of the railroads. In the past five years, Helen has been involved in the development and founding of an art school in the community which opened in January 2011 and of which she served as Dean. The school is designed to provide art education for children and adults and to develop job skills in the arts.

Previously she was a founder of the Allegheny Highlands Arts and Crafts Center in downtown Clifton Forge. It is a museum which serves the community with changing art exhibits, including many works by area artists and craftsmen which are for sale and a gift shop.

His colleagues elected him for four terms to represent the state gastroenterologists at the American College of Gastroenterology. Last year he was honored as the Physician of the year by the Vermont State Medical Society.

DONALD M. MILLER '38
MILITARY

Donald M. Miller was born in Millersburg, Ohio. He attended Purdue University and then the United States Naval Academy from which he graduated in 1943. After completion of training at the Submarine School in New London, Connecticut, he reported to the submarine DARTER, which was operating out of Brisbane, Australia. The DARTER fired the first shots of the Battle of Leyte Gulf sinking the ATAGO, the Flagship of Admiral Kurita's Japanese Imperial Fleet, and was later grounded while attacking the damaged Cruiser TAKAO. After the DARTER crew was rescued by the submarine DACE, he made another patrol on ANGLER, participating in another exciting rescue of the damaged submarine BERGALL and her crew.

He rejoined the DARTER survivors in Manitowoc, Wisconsin, to commission the MENHADEN, and was enroute to the Pacific when JAPAN surrendered. Subsequently he served on SEACAT and GRAMPUS and went back aboard to command the modernized MENHADEN. After Nuclear Power Training, he commissioned and commanded the Polaris Fleet Ballistic Missile Submarines ABRAHAM LINCOLN (GOLD CREW) and BENJAMIN FRANKLIN (BLUE CREW) and made six Strategic Deterrent Patrols.

Ashore he instructed at United States Naval Academy and the United States Navy Post Graduate School, attended Naval War College and National War College where he wrote a Prize-Winning Thesis "Economic Prospects of the United Arab Republic resulting from the Aswan Dam" which, unfortunately, NASSER never read. He earned a Masters Degree in International Affairs from George Washington University, was Naval Aide to Commander In Chief Caribbean Command in Panama, and served on the Staffs of the Joint Chiefs of Staffs and Chief of Naval Operations. He commanded the Fleet

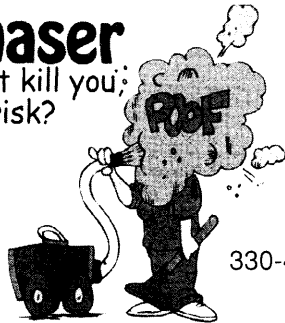



2013 SCHOLARSHIP APPLICATIONS NOW AVAILABLE

The application forms for the 2013 Alumni Scholarship Awards are now available both online and by written request. These scholarships awards are for \$500 each and are paid directly to those recipients who will be pursuing advanced education beyond high school in 2013. Eligibility is restricted to Lehman graduates or direct descendants of anyone who attended Canton Lehman High School between the years of 1938 and 1976.

Applications are now available online, in both Excel and PDF formats, on the alumni website (www.cantonlehman.org). The Excel format will allow you to complete the application online and save to your computer. The PDF format requires you to print a copy and complete by hand. Forms may also be requested by mail. Send requests to Lehman Alumni Scholarship Committee, P.O. Box 351, Louisville, OH 44641, and please enclose a self addressed stamped envelope. The form has been reformatted and should be easier to use, but will still have to be printed before mailing so that the other required items may be submitted with it.

As a reminder, the student's sponsor must hold an Association membership for both 2012 and 2013. If the Lehman attending primary sponsor is deceased, a direct descendant must

be an Association member for both 2012 and 2013. If they are not, they must join immediately and specify that they want to join for 2012 and renew for 2013.

All applications must be postmarked no later than May 1, 2013, and mailed to Canton Lehman Scholarship Committee, P.O. Box 351, Louisville, OH 44641. Those postmarked after that date will not be considered. Remember, normally 50 scholarships are awarded annually and the order in which they are received does factor into the final selection process. All applicants are eligible for up to two awards during their advanced education, however, a new application must be submitted in a subsequent year in order to be considered for the second award.

The Canton Lehman High School Alumni Association scholarship program was initiated in 1994. Since those first six recipients, the Association has awarded \$259,000 to 518 descendants of Lehman attendees. This success is the result of the continuing hard work and effort by members of the Association and very generous contributions by many of our former classmates who both appreciated their time at Lehman and believe in helping our children and grandchildren continue pursuing their education beyond high school.


CLASS OF 1942 REUNION – CLASS GIVES SCHOLARSHIPS!
