ALUMNI ASSOCIATION PICNIC

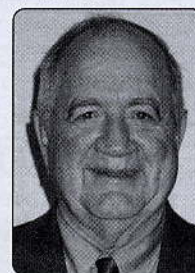

MESSAGE FROM THE PRESIDENT

After another great year, your Canton Lehman High School Alumni Association Board has awarded 51 scholarships this year. That means we will be awarding \$25,500 in scholarships this July. This will make 320 scholarships awarded with a total value of \$160,000. Not bad for an organization that was founded a little over ten years ago. All of the individuals who started and kept this organization going through the lean years should be immensely proud. Thank you and again thanks to this year's donors. From five dollars to one thousand dollars, it all adds up. Hopefully, next year we can award the same number of scholarships.

This year we had 67 qualified applications for scholarships. That's great! But then came the hard work, which is evaluating each application and deciding who will get the scholarships. We do have criteria that the selection committee uses to assist them in deciding the awards. For example, a senior in college who has not previously received an award will go to the top of the stack. We have a policy of awarding two \$500 scholarships during a student's college or technical school years. To distribute the awards to the greatest number of different students, we will not normally award a scholarship in two consecutive years, but if a student has been awarded one scholarship, they will be given extra consideration when they reapply after the two years. Because every application is an individual case, we consider our criteria only a guideline. Any special circumstances that we are aware of will be considered. Also, if a student did not receive an award this year, please get them to apply next year. Usually, they will get additional consideration if they reapply. I would be glad to discuss the process with anyone.

HILL GANG OUTING

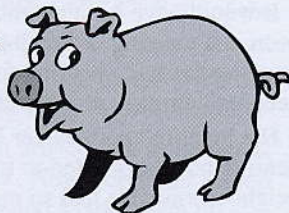
