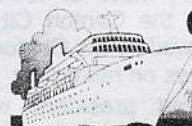

## BY-LAWS CHANGE

The association needs to change some wording in our by-laws to be acceptable for non-profit status. The following changes are to be made:

#### 2.1 - Purpose

This association is organized exclusively for charitable, humanitarian, educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### 13 - Dissolution

Upon the dissolution of the association, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of Stark County, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### 14 - Property and Funds

Real Property of the Organization is held and managed by the Board of Trustees, and only by its authority shall mortgages or other obligations be made chargeable to the real property of the Organization. The Board shall hold all trust funds for the Organization administering them with legal advice, in accordance with the requirements of state law, and for purposes indicated by the donors.

No part of net earnings of the Organization, good will Organization or programs, or trade name shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons without the consent of the full Board of Trustees by majority vote, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the Organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, Corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The above words are compatible with our constitution and by-laws but our wording was not acceptable for non-profit status. We need alumni to write a note stating this change is acceptable. Please do so immediately as returns must be received within 15 days after this mailing.
