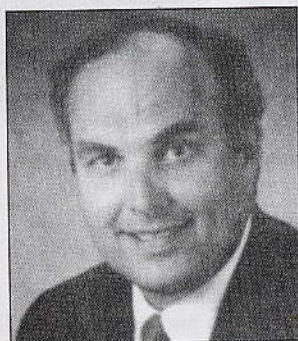

SCHOLARSHIP BANQUET

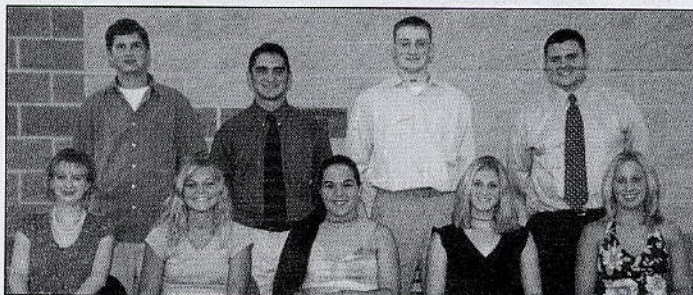
The Scholarship Banquet was well attended this year with over 85 people showing their support for the students.

The Scholarship Committee did an excellent job of choosing the 25 who would receive the \$500 scholarships. With over 100 requests it was not an easy job.

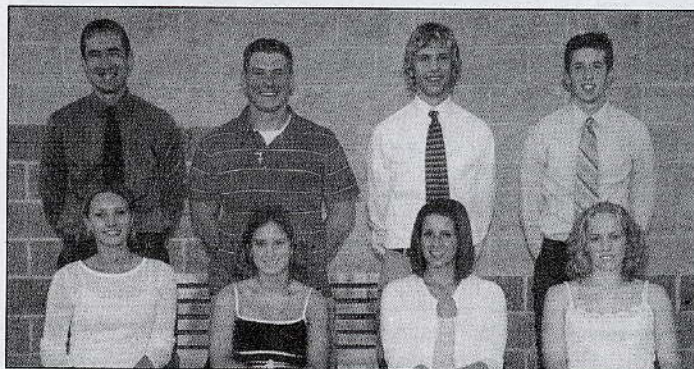

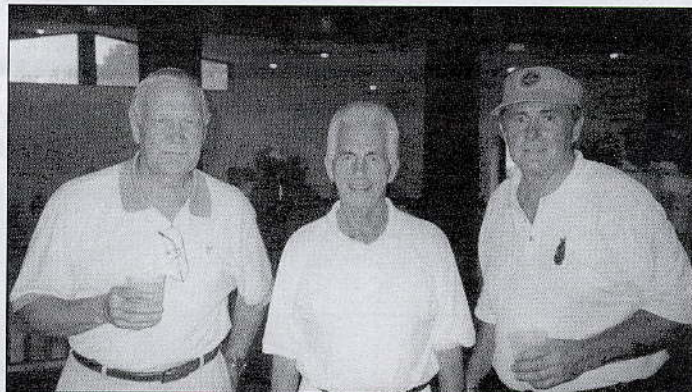
